She was murdered 4 days before Duncan Squires died, for reasons unknown to the Squires' family and the police authorities due to the fact that the Squires' family was unaware of Alexia's existence. The investigation into Alexia Weston's murder, discovered that Duncan Squires was also murdered causing a Judge to approve an Order for the exhumation of Squires' body.
